 - a) Flooding in Road and installation of a soakaway – John Williams DCC – A letter has been received by a Parishioners regards this and in it DCC state that the Parish Council have been holding up the project. The clerk will write to dispute this as permission from the Parish Council was given in June 2006.

 - f) Spring Closer on Small Gate to Childrens Play Area – The spring has been purchased and to be fitted shortly by the Chairman of the Parish Council – Mr Dave Wilson.
